I, the undersigned, hereby declare that, in accordance with the provisions of common law, in particular Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and the repeal of Directive 95/46 / EC (the so-called General Regulation on Data Protection / RODO), I transfer my personal data for the purpose and scope necessary to grant benefits by the Medical University of Lublin based at Al. data will be processed in order to archive the documentation, in accordance with the applicable laws and procedures in force at the University, as well as to the extent and periods necessary to seek possible claims.
